**Frequently Asked Questions About Free and Reduced Price School Meals**

Dear Parent/Guardian:

Children need healthy meals to learn. **Princeton City Schools** offers healthy meals every school day. Breakfast costs \$1.10 at the elementary schools \$1.35 at the Middle School, and \$1.65 at the High School; lunch costs \$2.25 at the elementary schools, \$2.65 at the Middle School, and \$2.90 at the High School. **Your children may qualify for free meals or for reduced-price meals.** Reduced price is currently being waived, and all qualifying “reduced status students will receive their meals at no cost(free). This packet includes an application for free or reduced-price meal benefits and a set of detailed instructions. Below are some common questions and answers to help you with the application process.

1. **Who can receive free or reduced-price meals?** All children in households receiving benefits from the Supplemental Nutrition Assistance Program (SNAP) or Ohio Works First (OWF); foster children that are under the legal responsibility of a foster care agency or court; children participating in their school’s Head Start program; and children who meet the definition of homeless, runaway, or migrant are eligible for free meals. Also, your children may receive free or reduced-price meals if your household’s income is within the limits on the federal income eligibility guidelines limits.

2. **How do I know if my children qualify as homeless, migrant or runaway?** If members of your household lack a permanent address; are staying together in a shelter, hotel or other temporary housing arrangement; relocate on a seasonal basis or; children live with you who have chosen to leave their prior family or household then the children may qualify as homeless, migrant or runaway. If you have not been told your children will receive free meals, please call or email your child’s school principal or the District Liaison, Deborah Birch, Director of EMIS at 513-864-1000 to see if they qualify.
3. **Do I need to fill out an application for each child?** No. Use one free and reduced-price school meal application for all students in your household. We cannot approve an application that is not complete. Please submit all required information. Return the completed application to your child’s school.
4. **Should I complete an application if I received a letter this school year saying my children are approved already for free meals?** No, but please read the letter carefully and follow the instructions. If any children in your household were missing from the eligibility notification, contact the Food Service Department immediately (513-864-1022 or 513-864-1023).
5. **Can I apply online? Yes!! You are encouraged to complete an online application instead of a paper application if possible. The online application has the same requirements and will request the same information as the paper application. Furthermore, once you have completed the online application you will automatically know if your child(ren) qualify. Visit our department website at [www.princetonschools.net](http://www.princetonschools.net) to begin or to learn more about the online application process.**
6. **Contact the Food Service Department (513-864-1022) if you have any questions about the online application.**
7. **My child’s application was approved last year. Do I need to complete another application? Yes.** Your child’s application is valid for that school year and for the first few days of this school year, 10/1/20.

You are required to submit a new application unless the school told you that your child is eligible for the new school year. If you do not send in a new application that is approved by the school or you have not been notified that your child is eligible for free meals, your child will be charged the full price for meals on 10/2/20.

8. **I receive WIC benefits. Can my child(ren) get free meals?** Children in households participating in WIC may be eligible for free or reduced-price meals. Please complete and submit an application.
9. **Will the information I give be checked?** Yes, we may also ask you to send written proof.
10. **If I do not qualify now, may I apply later?** Yes. You may apply at any time during the school year. For example, children with a parent or guardian who becomes unemployed may become eligible for free and reduced-price meals if the household income drops below the income limit.
11. **What if I disagree with the school's decision about my application?** You should talk to school officials. You also may ask for a hearing by calling our District Liaison, Deborah Birch, at 513-864-1000.
12. **May I apply if someone else in my household is not a U.S. citizen?** Yes. You or your child(ren) members do not have to be a U.S. citizen to qualify for free or reduced price meals.
13. **What if my income is not always the same?** List the amount that you normally receive. For example, if you normally make \$1,000 each month, but you missed some work last month and only made \$900, submit the report with the routine amount of \$1,000 per month. If you normally get overtime, include it, but do not include it if you only work overtime sometimes. If you have lost a job or had your hours or wages reduced, use your current income.
14. **What if some household members have no income to report?** Household members may not receive some types of income that are asked for you to report on the application or may not receive income at all. When this happens, please write a 0 in the field. However, if any income fields are left empty or blank, those also will be counted as zeroes. Please be careful when leaving income fields blank.
15. **We are in the military. Do we report our income differently?** Your basic pay and cash bonuses must be reported as income. If you get any cash value allowances for off-base housing, food, or clothing, it also must be included as income. However, if your housing is part of the Military Housing Privatization Initiative, do not include your housing allowance as income. Any additional combat pay resulting from deployment is also excluded from income.
16. **What if there is not enough space on the application for my family?** List any additional household members on a separate piece of paper and attach it to your application. Contact your child's school to receive a second application.
17. **My family needs more help. Are there other programs we might apply for?** To find out how to apply for Ohio SNAP or other assistance benefits, contact your local assistance office or call 877-852-0010.
18. **Will my information be shared with other programs with the district?** Yes, if you fill out and sign the "Sharing Information With Other Programs" page after the meal application. You must fill out all information for it to be shared.

## **INSTRUCTIONS FOR APPLYING**

***A household member is any child or adult living with you.***

**IF YOUR HOUSEHOLD RECEIVES BENEFITS FROM THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM (SNAP) OR OHIO WORKS FIRST (OWF), FOLLOW THESE INSTRUCTIONS:**

**Part 1:** List all household members and the school name and grade level for each child.

**Part 2:** List the 7 or 10-digit case number for any household member (including adults) receiving SNAP or OWF benefits.

**Part 3:** Skip this part.

**Part 4:** Skip this part.

**Part 5:** Sign the form. The last four digits of a Social Security Number are **not** necessary.

**Part 6:** We are required to ask for information about your children's race and ethnicity. This information is important and helps to make sure we are fully serving our community. Responding to this section is optional and does not affect your children's eligibility for free or reduced price meals.

**IF NO ONE IN YOUR HOUSEHOLD RECEIVES SNAP OR OWF BENEFITS AND IF ANY CHILD IN YOUR HOUSEHOLD IS HOMELESS, MIGRANT OR RUNAWAY, FOLLOW THESE INSTRUCTIONS:**

**Part 1:** List all household members and the school name and school grade level for each child.

**Part 2:** Skip this part.

**Part 3:** If any child you are applying for is homeless, migrant, or a runaway, check the appropriate box and call your school principal or District Liaison, Deborah Birch, at 513-864-1000.

**Part 4:** Complete only if a child in your household isn't eligible under Part 3. See Instruction for all other households.

**Part 5:** Sign the form. The last four digits of a Social Security Number are **not** necessary if you didn't need to complete in part 4.

**Part 6:** We are required to ask for information about your children's race and ethnicity. This information is important and helps to make sure we are fully serving our community. Responding to this section is optional and does not affect your children's eligibility for free or reduced price meals.

**IF YOU ARE APPLYING FOR A FOSTER CHILD, FOLLOW THESE INSTRUCTIONS:**

**If all children in the household are foster children:**

**Part 1:** List all foster children and the school name and grade level for each child. Check the box indicating the child is a foster child.

**Part 2:** Skip this part.

**Part 3:** Skip this part.

**Part 4:** Skip this part.

**Part 5: Sign the form.** The last four digits of a Social Security Number are **not** necessary.

**Part 6:** We are required to ask for information about your children's race and ethnicity. This information is important and helps to make sure we are fully serving our community. Responding to this section is optional and does not affect your children's eligibility for free or reduced price meals.

**If some of the children in the household are foster children:**

**Part 1:** List all household members and the name of school and grade level for each child. For any person, including children, with no income, you must check the "No Income" box. Check the box if the child is a foster child.

**Part 2:** If the household does not have a SNAP or OWF 7 or 10-digit case number, skip this part.

**Part 3:** If any child you are applying for is homeless, migrant, or a runaway check the appropriate box and call your school principal or District Liaison, Deborah Birch, at 513-864-1000. If not, skip this part.

**Part 4:** Follow these instructions to report total household income from this month or last month.

- **Box 1–Name:** List all household members with income.
- **Box 2 –Gross Income and how often it was received:** For each household member, list each type of income received for the month. Check the appropriate box to note how often the person receives the income - weekly, every other week, twice a month, or monthly. For earnings, list the gross income - not the take-home pay. Gross income is the amount earned *before* taxes and other deductions and can be found on your pay stubs. For other income, list the amount and check the box to note how often each person received assistance from welfare, child support, alimony, pensions, retirement, Social Security, Supplemental Security Income (SSI), Veteran's benefits (VA benefits), and disability benefits. Under *All Other Income*, list Worker's Compensation, unemployment or strike benefits, regular contributions from people who do not live in your household, and any other income. Do not include income from SNAP, FDPIR, WIC, federal education benefits and foster payments received by the family from the placing agency. For **ONLY** the self-employed, report income after expenses under *Earnings from Work*. This is for your business, farm, or rental property. **ALL OTHER HOUSEHOLDS (INCLUDING WIC HOUSEHOLDS) FOLLOW THESE INSTRUCTIONS:**

**Part 1:** List all household members and the school name and grade level for each child. For any person, including children, with no income, you must check the “No Income Box”.

**Part 2:** If the household does not have a SNAP or OWF 7 or 10-digit case number, skip this part.

**Part 3:** If any child you are applying for is homeless, migrant, or a runaway check the appropriate box and call or call your school or District Liaison, Deborah Birch, at 513-864-1000. If not, skip this part.

**Part 4:** Follow these instructions to report total household income from this month or last month.

- **Box 1 – Name:** List all household members with income.

Responding to this section is optional and does not affect your children’s eligibility for free or reduced price meals.

**SPECIAL NOTICES – IMPORTANT – PLEASE READ**

**We have in place at all of our school buildings the Alternate Meal program for those students who do not have any money to purchase lunch. Our new Point of Sale system allows up to a \$10 credit to be accrued. (This \$10 credit can only be applied toward a meal. It cannot be used for snacks or ala carte items.) After that, no credit will be given. This applies to all existing negative balances from last school year. Please make sure your students accounts are current to purchase meals.**

**The school system does not desire to give any student an Alternate Meal. We strongly encourage parents/guardians to monitor accounts to prevent their child from receiving an alternate meal. It is the parent’s/guardian’s responsibility to provide the means for their child to be properly fed and ready to learn. In order to do this, they should: provide the money for their child to purchase a school meal, complete the free/reduced meal application to determine eligibility for free or reduced meals, or send a meal from home with your child.**

**All free and reduced meal applications are processed in the order they are received in the Food Service Office. It may take up to ten working days for your family’s application to be processed (especially during the beginning of the school year). Parents/Guardians are responsible for payment of all school meals and any accumulated charges until their application is approved**

**Prepayment into your child(ren)’s meal accounts is strongly encouraged. You can send cash, check, or money order to school with your child(ren). Please make sure that whatever you send is clearly marked for your child’s meal account. If you wish to use a credit card to make payments, you may use PAYSCHOOLS. You can easily set up payments into your child’s meal account and receive notices from PAYSCHOOLS of your child’s meal account balance. Log on to our district website and there is a link to PAYSCHOOLS for your convenience.**

**If you have a child that is “directly certified” by the state (this means your child is receiving some type of assistance from the state of Ohio), you will receive a notice from us prior to the start of school. Directly certified students automatically receive free meals and this applies to all school age siblings in their household. When you receive this notification, please make sure all children in your household are listed on this letter. If they are not listed on the letter, you must contact the Food Service Office as soon as possible so all children in your household are changed over to free status.**

**As the new school year begins, we want to remind you again that applications processed last school year will be in effect until October 1, 2020. This is the expiration date for last school year's applications. It is very important that a new application is completed for this school year and turned in as soon as possible to your child(ren)'s school. Only one application per family needs to be completed.**

**New kindergarten students starting this year are eligible to be considered under their family's free and reduced application or direct certification from last year. If your school age children received free/reduced meals last year, your new kindergarten student this school year would be eligible for the same free/reduced meals this school year until October 1, 2020, when all of last year's applications and direct certifications expire. Our problem is we do not know if these new students are eligible unless the family or school contacts us to update our POS system. Please contact us in the Food Service Office at 513-864-1022 or 513-864-1023 if you have new kindergarten students that would already be eligible for free/reduced meals until October 1, 2020.**

**Privacy Act Statement: This explains how we will use the information you give us.**

The Richard B. Russell National School Lunch Act requires the information on this application. You do not have to give the information, but if you do not, we cannot approve your child for free or reduced price meals. You must include the last four digits of the social security number of the adult household member who signs the application. The last four digits of the social security number is not required when you apply on behalf of a foster child or you list a Supplemental Nutrition Assistance Program (SNAP), Ohio Works First (OWF) case number or other identifier for your child or when you indicate that the adult household member signing the application does not have a social security number. We will use your information to determine if your child is eligible for free or reduced price meals, and for administration and enforcement of the lunch and breakfast programs. We MAY share your eligibility information with education, health, and nutrition programs to help them evaluate, fund, or determine benefits for their programs, auditors for program reviews, and law enforcement officials to help them look into violations of program rules.

In accordance with Federal civil rights law and U.S. Department of Agriculture (USDA) civil rights regulations and policies, the USDA, its Agencies, offices, and employees, and institutions participating in or administering USDA programs are prohibited from discriminating based on race, color, national origin, sex, disability, age, or reprisal or retaliation for prior civil rights activity in any program or activity conducted or funded by USDA.
